MAH-MBA/MMS CET 2023 for A.Y. 2023-24

RE-EXAMINATION OF CANDIDATES OTHER WHO COULD NOT COMPLETE MAH-MBA/MMS CET 2023 DUE TO TECHNICAL ISSUES WITHIN MANDATORY EXAMINATION TIME AND WISH TO REAPPEAR AND OF THOSE CANDIDATES OTHER THAN PWD CANDIDATES WHO GOT EXAMINATION TIME OF 180 MINUTES INSTEAD OF MANDATORY 150 MINUTES.

MAH-MBA/MMS CET 2023 for A.Y. 2023-24 was conducted on 25th & 26th March 2023 at 191 centres in Maharashtra and some other states as per the schedule declared on CET Cell web portal .On account of complaints received by the CET Cell about some candidates getting less than mandatory examination time due to various technical issues during the above said examination and also some candidates other than those belonging to the PWD category getting 180 minutes instead of mandatory 150 minutes in the said examination , the CET Cell instituted an Enquiry Committee to look into all such complaints about the examination . On the basis of the Enquiry Committee Report, the CET Cell has decided to hold re examination of

1. Candidates who could not complete the examination due to technical issues within mandatory examination time and <a href="https://www.mish.com/wi

and

2. Candidates other than those belonging to the PWD category who got examination time of 180 minutes instead of mandatory 150 minutes. It may be noted that the earlier examination of such candidates who got examination time of 180 minutes instead of mandatory 150 minutes due to a technical issues <u>stands cancelled</u>.

The Re-Examination for both 1) and 2) above is scheduled on Thursday 27/04/2023 from 9 am to 11 30 am. The CET result of all these candidates will be declared on the basis of the Re Examination only.

The application form for the Re-Examination will be made available from 06/04/2023 up to 11/04/2023 to these candidates at http://cetcell.mahacet.org.

The above mentioned candidates will also be intimated through their registered e-mail and SMS on their registered cell phone number . Please note that it will be the responsibility of the eligible candidates to print their admit card and appear for the examination at the centre as per the time and schedule mentioned in their Admit Card.
