ADMISSION NOTICE FOR FIRST YEAR OF POST HSC DIPLOMA COURSES IN PHARMACY, HOTEL MANAGEMENT & CATERING TECHNOLOGY AND SURFACE COATING TECHNOLOGY FOR ACADEMIC YEAR 2020-21

In accordance with the Maharashtra Government Extraordinary Notification No.232 published on 05/07/2018, Government of Maharashtra vide Government Resolution Higher and Technical Education Department No. Sankirn-2019/(C.R.06/19)TE-5 dated 06/02/2019, Director, Technical Education is the Competent Authority for implementation of all the activities related to admission of Diploma Courses under the purview of Directorate of Technical Education, Maharashtra State.

This Notice is being issued for Online Registration & uploading of documents, Documents Verification and Application Form Confirmation for admissions to First Year of Post HSC Full Time Diploma in Pharmacy, Surface Coating Technology And Hotel Management & Catering Technology programs in the Government, Government Aided, University Managed and Unaided private educational institutes for the Academic Year 2020-21 in the State of Maharashtra.

However considering the COVID-19 outbreak and present lockdown, it is essential to maintain the social distancing and avoid the crowding of parents and students at the designated Facilitation Centers(FC).

In view of this, the concept of e-Scrutiny in addition to the Physical Scrutiny of the documents is introduced by the Competent Authority. The candidate shall select the mode of scrutiny depending upon his/her convenience for online filling & confirming the application form.

- **Method 1:-** The Candidate shall register online and select the e-Scrutiny Mode. The candidate shall fill & submit online application form and upload the required documents from anywhere through the computer connected to internet and he/she need not have to visit personally for verification and confirmation of the application form. His/Her application & documents shall be verified and confirmed by the designated Facilitation Center through e-Scrutiny Mode.
- **Method 2:-** The Candidate shall register online through mobile (Smart phone) or computer and select the Physical Scrutiny Mode. The candidate who does not have any mobile (Smart phone) or computer facility for registration shall visit the nearest FC for registration & scheduling. The registered candidates shall book convenient slot [date & timing] of FC. The candidate need to fill online application form, scan & upload required documents by themselves free of cost at FC. Candidate shall visit FC as per schedule and do the verification and confirmation of application form free of cost at FC by maintaining social distancing norms.

Aspiring candidates are informed to read the Rules, process and instructions given in the Information Brochure carefully. The Information brochure is published on <http://posthscdiploma2020.dtmaharashtra.gov.in> for download.

Post HSC Diploma in Pharmacy

Maharashtra State / All India Candidates

- (i) The Candidate should be an Indian National.
- (ii) Passed 10+2 examination with Physics and Chemistry as compulsory subjects along with Mathematics/ Biology subject.

Post HSC Diploma in Surface Coating Technology
Maharashtra State / Jammu - Kashmir and Ladakh Migrant Candidates
(i) The Candidate should be an Indian National. (ii) Passed HSC Science with subjects English, Physics, Chemistry and Mathematics.
Post HSC Diploma in Hotel Management & Catering Technology
Maharashtra State / Jammu - Kashmir and Ladakh Migrant / All India Candidates
(i) The Candidate should be an Indian National. (ii) Passed 10+2/ HSC examination or its equivalent with at least 35% aggregate marks.

NRI/OCI/PIO/CIWGC/FN candidates – There are no seats sanctioned by AICTE, PCI for A.Y. 2020-21

Important Note:

- Other than Maharashtra State Candidates shall be eligible for Institution quota only.
- In case the result of the candidate is given in terms of grades, such candidates are required to submit the graded result into the equivalent marks authorized from the concerned Institute /Board. The eligibility shall be decided on the basis of equivalent marks.

Online Registration for Admission: -

1. The candidates should apply online on <http://posthscdiploma2020.dtemaharashtra.gov.in> as per schedule.
2. Candidates are required to pay application fee as given below only by online mode through **Credit Card/ Debit Card/ Net Banking** (No other mode of payment shall be permitted). Application fee paid is non-refundable.

Important Note: -

- All types of candidates** aspiring for admission under CAP seats shall register; get Documents Verified & Application Form confirmed either by E-Scrutiny Mode or Physical Scrutiny Mode. Such eligible registered candidates shall be considered for CAP Merit and admission through CAP.
- The candidates aspiring for admission for Institutional Quota, seats remaining vacant after CAP, it is **mandatory** to get registered, documents verified and confirmation of application either by E-Scrutiny Mode or Physical Scrutiny Mode. such candidates must apply separately to Institutes for admissions. Merit of such candidates shall be prepared by the Institute at the institute level.

Important Instructions for candidates:

- The Candidates opting Physical Scrutiny Mode shall strictly follow the guidelines related to COVID-19 outbreak issued by the Government of Maharashtra from time to time. It is essential to maintain the social

- distancing and avoid the crowding of the aspiring candidates and parents at the designated Facilitation Centers.
2. If candidates fails to confirm online filled application form as per the mode selected either by E-Scrutiny Mode or Physical Scrutiny Mode then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission for both CAP as well as Non-CAP process.
 3. All Backward Class candidates (for VJ/DT- NT(A), NT(B), NT(C), NT(D), OBC, SBC, SEBC Category) shall produce Non Creamy Layer certificate valid up to 31st March 2021 as per the mode selected either by E-Scrutiny Mode or Physical Scrutiny Mode. If these candidates are not able to produce the Non Creamy Layer certificate, then such candidates will be treated as GENERAL category candidates and such candidates will not be able to claim Reserved seats under the admission process.
 4. During E-Scrutiny Mode or Physical Scrutiny Mode, Candidate shall produce the relevent & valid documents to substantiate the claim made in the application form. In case of non submission of the relevent documents, the candidate shall lose such claims made in the application and applications of such candidates shall be confirmed without considering such claims.
 5. Candidates who have registered as a reserved category candidate but unable to produce required certificate for reservation claim during documents verification stage either by E-Scrutiny Mode or Physical Scrutiny Mode shall be treated as GENERAL category candidates and have to pay difference of fee of ₹ 100/- at through online mode only.
 6. Candidates opting for Physical Scrutiny Mode shall carry all required documents in original for scrutiny at FC.
 7. The further schedule for Filling & Confirmation of Option Form for CAP Rounds, CAP Allotment, Acceptance of seat, reporting to Institutes by candidates, cut off date of admission etc. shall be declared after declaration of the Final Merit List and shall be published on website: <http://posthscdiploma2020.dtemaharashtra.gov.in>

General Notes:

1. Candidate who have opted Physical Scrutiny Mode can avail the IT facility which is available at Facilitation Centre (FC) free of cost for submission, scanning and uploading documents, and confirmation of Application form . The candidate shall adhere to the COVID-19 guidelines issued by the GoM time to time during reporting at the FC.
2. For Physical Scrutiny Mode : List of FC's is available on website and these FC's shall remain open during the schedule between 10.30 a.m. to 5.30 p.m.
3. Eligibility, Rules & regulations for admission shall be made available on the website.
4. The schedule displayed above is provisional and may change under unavoidable circumstances.
